This rulemaking will determine whether it is appropriate to establish standards for these other types of electric distribution transformers.

Abstract: EPACT 2005 establishes test procedures for numerous consumer products and commercial equipment. In order to maintain the consistency and completeness of the Department's appliance test procedure regulations codified in 10 CFR 430 and 431 and to aid interested parties in locating and using the new regulatory information, DOE plans to promulgate test procedures for the products in EPACT 2005. However, DOE will need to review these test procedures to determine their adequacy for adoption in the Code of Federal Regulations and may conduct multiple rulemakings to adopt test procedures for these products. This rulemaking(s) encompasses the following products and equipment: Commercial refrigerators, freezers, and refrigeratorfreezers; remote condensing commercial refrigerators, refrigerator-freezers, and freezers; commercial icemakers; residential dehumidifiers; commercial clothes washers; ceiling fans; illuminated exit signs; medium base compact fluorescent lamps; torchieres; traffic signal modules and pedestrian modules; small commercial package airconditioning and heating equipment; large commercial package airconditioning and heating equipment; very large commercial package airconditioning and heating equipment; commercial prerinse spray valves; and low-voltage dry-type distribution transformers; and battery charges and external power supplies.

**Abstract:** With this rulemaking, the Department of Energy (DOE) is amending its test procedure for residential central air conditioners and heat pumps. The rulemaking implements test procedure changes in such areas as small-duct, high-velocity systems, multiple-split systems, twocapacity units, and the referencing of current ASHEAE standards. The amendments also clarify issues associated with sampling and rating both tested and untested systems. DOE believes that the amendments will not cause products to fail to meet the energy standards in effect either before or after January 23, 2006.

**Abstract:** The Department of Energy (DOE), Office of Energy Efficiency and

Renewable Energy, defines rule modifications to implement changes to the Renewable Energy Production Incentives (REPI) program required by section 202 of the Energy Policy Act of 2005, Public Law 109-58. REPI provides for production incentive payments to owners or operators of qualified renewable energy facilities, subject to the availability of appropriations. These Energy Policy Act modifications relate primarily to allocation of available funds between owners or operators of two distinct groups of qualified facilities, incorporation of additional ownership categories, extension of the eligibility window and program termination date, and expansion of applicable renewable technologies. In addition to the changes required by the Energy Policy Act of 2005, the DOE is modifying the method for accrued energy accounting. Other minor changes are incorporated, as needed, to update the rule.
